## GREENPLAY® PROFORMANCE CORK (PFC) INFILL SYSTEM-LIMITED WARRANTY

Greenplay Organics LLC will warrant the Greenplay<sup>®</sup> PFC ProFormance Cork (140 kg/M³ density) infill product against defects in material manufacturing and durability to include, but not limited to premature wear and excessive compaction for a full term of the turf warranty up to 10 years and subject to the following exclusions and stipulations:

- The infill must be installed in accordance with written instructions provided by Greenplay Organics LLC, which will be based on the turf specifications and accepted by the Installer. All applications and installation procedures subsequently set forth must be documented with field reports to verify: 1) quantity by weight of cork infill 2) quantity by weight of blended sand 3) infill depth verification upon installation 4) proper topping off to maintain specified infill depth.
- This Limited Warranty is implied for Greenplay® organic infill against excessive degradation in conformance of Industry standards & verified by ASTM tests when it can be proven that the product has been maintained in strict accordance with the procedures set forth by the *Greenplay® Granular Cork Infill Maintenance Procedures Manual for a Synthetic Turf Field*.
- It is acknowledged that Greenplay® will be utilized in synthetic turf for field events such as football, soccer, baseball, lacrosse, field hockey (and similar), marching band, general recreation games, practices and that these uses are purposes for which the surface and infrastructure has been designed to support. Specifically excluded from this warranty are any damages to the organic infill component resulting from improper care and maintenance such as the application of high static loads, transit of vehicles on field without the appropriate low-psi turf specification tires, transit of vehicles on field exceeding two tons, reckless operation of vehicles, improper procedures for snow removal or overall lack of seasonal maintenance and routine grooming as specified in the maintenance manual.
- Material loss due to flooding or excessive run-off, whether a result of "Act of God", grade exceeding 1.5%, poor base drainage or unfavorable site conditions are excluded by this warranty.

The sole and exclusive remedy of this warranty shall be expressly limited to replacement of any infill defective in manufacture or performance with new material and without charge to Owner, and expressly excludes consequential or liquidated damages including, but not limited to: lost sales, cancelled events, injury to property, personal injury or any other damages.

If any claims do arise; the warranty holder must provide Greenplay Organics LLC by written notice within two (2) days of the discovery of any defect and supply the details, including photos with copies of the use and maintenance logs specific to the area of the defect in material. After notification and receipt of aforementioned details and analysis, an authorized Greenplay Organics LLC representative will inspect and verify the alleged defect within four (4) business days anywhere in North America.

All materials must be paid in full to initiate the terms of this Warranty. The warranty period begins when the infill is installed and put in use; delay of the final payment shall not toll the running of the warranty period.
